## **Topic-2: The rights of autistic children**

### **Notes:**

- **Rights:** Correct in one's opinion or judgement.
- Autism: 'Autism' is a developmental disorder characterized by difficulties with social interaction and communication and by restricted and repetitive behavior.
- **Autism is a problem** of developmental disorder that is a set of related condition with social interaction, communication and behavior.

# **Topic-3: The violation of children's rights**

# **Notes:**

- Violation: An action of violating someone or something.
- Child right violation: Violence against children in all its forms as well as discrimination against girls, child marriage, children with disabilities, homeless children, refugee children etc.
- Child labor is illegal below the age of 18 in Bangladesh.

- **Child trafficking means** transporting child elsewhere to do illegal work.
- The term 'child labor' is defined any form of work that deprives children of their childhood and is harmful to their physical and mental development.

### **Activities:**

a) Discuss with your teacher — what you would do if you saw children being violated in these ways. Show the examples of child right violation.

At first concerned that a child is a victim of abuse, then have to report in my local state of child protection organization.

### examples of child right violation:

- Some children are deprived of their right to education, because their family cannot afford to send them to school.
- Some children have to work in the fields, in brick kilns, or in factories.
- Some children are homeless, especially in the cities, because their family cannot afford housing.
- Sometimes children are punished physically, although it is illegal.
- Some children are trafficked, which means transporting them elsewhere to do illegal work.
- **b) Group activity-----** act out a role-play. Choose one of the examples opposite and act out how you would try to report the offence. One should be the victim, one a witness, and one be someone in authority.
- c) Pair work -----Write how do children benefit more from education than from laboring for their family?
  - Education gives us knowledge of the world around us and changes us into something much better.
  - It changes our perspective of looking at life.
  - It also promotes individual freedom and development of the children.

## **Topic-4: The violation of women's rights**

### **Notes:**

- **Violation:** An action of violating someone or something.
- Women's rights: Women's rights are the rights and entitlements claimed for women and girls worldwide. These rights include the right to live, free from violence, to be educated, to own property, and to earn a fair and equal wage.
- **Violence against women** by which women are forced into a subordinate position compared with and can take many forms.

Examples of violation of women's rights:

- i) Girls may not receive equal education to boys.
- ii) Women may not be given equal jobs to men.
- iii)Women at work may not receive equal pay to men.
- We should give to our household helpers the proper pay or food or health care that they are entitled to.

## **Activities:**

a) Discuss with your teacher — whether girls and women are treated equally to men. What examples have you seen of unequal treatment? What can you do about it? How can we change people's attitudes?
