5. F.B.I
6. Legal Executive

**Discuss about some Legal occupations:**

**1. Police :** The civil force of a state who is responsible for the prevention and detection of crime and the maintenance of public order. There is a different type of police. For example,

1. Traffic police
2. Metro beatman police
3. C.I.D
4. R.A.B
5. Special jurisdiction police.

**The responsibilities of the polices:**

1. They work to protect the law and order of the country.
2. Their major responsibility is to bring the criminal to the court.
3. They also play a vital role ensuring orderly movement of transport on the street.

4.They also help the people to move safely on the road.
