Topic-3: The violation of children's rights

Note:

• At first read the related topic from the text book.

• Violation:

An action of violating someone or something.

The definition of a violation is a breach (break/neglect) of a law or of a code of behavior. Example: when you drive your car faster than the speed limit, this is an example of a violation of the law or, when you read someone's diary this is an example of a violation of privacy.

- <u>Child right violation:</u> Violence against children in all its forms as well as discrimination against girls, child marriage, children with disabilities, homeless children, refugee children etc.
- Symbol of Child Rights:





• Child labour:

The term 'child labour' is defined any form of work that deprives children of their childhood and is harmful to their physical and mental development.



• Child labor is illegal:

Child labor is illegal below the age of 18 in Bangladesh.

• Example: Some children have to work in the fields, in brick kilns, or in factories, etc.

• Causes and examples of child right violation:

- i) Some children are deprived of their right to education, because their family cannot afford to send them to school.
- ii) Some children have to work in the fields, in brick kilns, or in factories.
- iii) Some children are homeless, especially in the cities, because their family cannot afford housing.
- iv) Sometimes children are punished physically, although it is illegal.
- v) Some children are trafficked, which means transporting them elsewhere to do illegal work.

• Bad effects of child labour:

- i) Psychological effects
- ii) Growth deficiencies
- iii) Physical injuries
- iv) Health problems
- v) Premature ageing
- vi) Malnutrition
- vii) Depression
- viii) Drug dependency
- ix) Lack of education etc.

• Child trafficking:

Child trafficking means transporting child elsewhere to do illegal work.





Reasons of child trafficking. Example:

- 1. benefit fraud.
- 2. forced marriage.
- 3. domestic slavery like cleaning, cooking and childcare.
- 4. forced labor in factories or agriculture.
- 5. committing crimes, like begging, theft, working on cannabis farms or moving drugs.
